**MINUTES OF 2018 ANNUAL CONGREGATIONAL MEETING**: Pages 1-3 A motion was made by Melinda Zorn and seconded by Jim Semon to accept the 2019 St. John's Annual Meeting minutes from the January 27, 2019 meeting. Motion Passed by unanimous voice vote. A motion was made by David Zorn and seconded by Ron Zorn to accept the 2019 St. John's Special Congregational Meeting held on June 30, 2019. Motion Passed by unanimous voice vote.

Ron has acted as temporary treasurer since Colleen's resignation in December. He also thanked Bonny Ambos and Kathy Strayer who have resigned as counters for the church. Candice and Clem Rudy continue to do outstanding work for St. John's as counters and by sending individual end of year reports of donations to each member of the congregation. He also expressed gratitude to Ray Vance for creating our online giving app found on our website. Ron announced that the team is pleased that Kathy Scheid has graciously agreed to come on board the Finance Team replacing Jim Moore. **Candice Rudy, Kathy Scheid and Ron Zorn** reported records for 2020 to be in excellent condition and no exceptions were found.

## FINANCIAL REPORTS

TREASURER'S REPORT: Ron Zorn Pages 8-13 Ron expressed his thanks to the congregation for their outstanding financial support this past year. We ended the year with a positive balance of \$25,000 because of some expenses being less than in past years, but mostly because of generous weekly donations from the members of St. John's.

ENDOWMENT COMMITTEE REPORT and FINANCIAL REPORT: Page13-14 John Miller/Ron Zorn John Miller reported that the Endowment Fund had a very successful year with a 21% increase. Requests for grants must be received by October 15<sup>th</sup>. This is a change made by the Endowment Committee so that they have time to process the grant requests in order to be able to announce them by the time of the annual meeting. Requests can be for projects happening outside the St. John's community. The committee encourages congregation members to start applying for 2020.

SCHOLARSHIP COMMITTEE: Sue Lucht Page 15 Sue reported that two \$600 scholarships were given in 2019. In May, 2020 there will be a fund raiser with applications due in June. The committee is always looking for applicants of any age.

#### **OLD BUSINESS**

FLAMe: Bob Krawetzki reported that the FLAMe Board has disbanded. They have about \$3000 left in their treasury. They will donate \$500 to St. Paul's boys' basketball program, \$200 to the upcoming opiate seminar and the rest will be distributed to Joytime, Giving Garden and Life Tree Café'.

#### **NEW BUSINESS**

CONSTITUTION: Kevin Young and his committee have been working on rewriting St. John's Constitution because the Synod has asked that all constitutions now be one document rather than three: Constitution, By Laws and Continuing Resolutions. All three are now included in the Constitution and considered as one document. Continuing Resolutions are the only part of the document that can be added and/or amended by St. John's Council members. This Constitution represents our total transition to the Team format for representation on Council. He thanked Ann Voight for all of her preparatory work on the document and his committee for their input during this process. Bill Lucht moved and Jim Semon seconded that we accept the new Constitution as written in its current version. Motion passed by unanimous voice vote.

ENDOWMENT FUND GRANTS: John Miller/Ron Zorn Page 16. Bill Lucht moved and Barry Laird seconded that we approve payment of the 2019 grants payable in 2020 later listed in the annual report. Motion passed by unanimous voice vote.

**NOMINATING COMMITTEE REPORT:** Kevin Young Page 17 Kevin thanked Heather Ruggles and Jenna Stacy for their help in recruiting people for this year's nominations. All positions are listed on Page 17 of the annual report.

ELECTIONS OF COUNCIL AND ENDOWMENT COMMITTEE MEMBERS: Bob Krawetzki moved and Ray Witt seconded that we accept the slate of nominations as listed on page 17 of the annual report. Motion passed by unanimous voice vote.

2020 BUDGET PRESENTATION- Ron Zorn Pages 18-20 Ron Zorn presented the proposed 2020 budget that has been recommended by Council. The pastor's salary was adjusted based on the Synod's guidelines. There was a correction made on page 20 of the annual report on the total of the approved 2020 budget. The total of the 2020 budget should have been \$164,093 and not the \$166, 093 that was listed. John Miller moved and Samantha Lane seconded that we accept the budget as corrected. Motion passed by unanimous voice vote. 2

Ann thanked all Council members for their commitment to St John's which significantly contributed to the successful year. Pastor Stacy thanked Ann for all the work she has done in the many positions she's served over the years, especially this one as president.

**ADJOURNMENT:** There being no further business on motion by Kathy Strayer and seconded by John Miller, the meeting was adjourned. Upon closing, Pastor Stacy lead us in the Lord's Prayer followed by Ann Voight leading the Benediction. Reverend Paul Stengel followed with a blessing for the potluck meal immediately following in the fellowship room downstairs.

# Worship Team – Team Leader: Sandy Thompson

The Worship Team consists of Pastor Stacy, Doreen Ross, Morgan Noon, Allison Young, Barry & Kerry Laird, Jerrie Krawetzki, and Sandy Thompson as team leader. I thank them for their support and willingness to be an integral part of the Worship Team.

2020 began with preparing for our Lenten season and Easter at our January meeting. In person worship shut down in March due to the Covid 19 pandemic. Covid brought new challenges for St. John's Worship Team and the whole parish. A new out-reach to our members and an outreach into our community to join us for worship. We began worshipping on Zoom weekly with the hopes we would be back in the sanctuary at Easter. As the pandemic escalated Easter worship took place on Zoom. The worship Team met in June in hopes to plan for summer worship but again due to the stay at home order our summer outside worship had to be cancelled. At our meeting, discussion took place to expand worship to the church parking lot via radio transmitter for members who were not able to use Zoom. Ann Voight contacted several congregations who were already offering parking lot worship. Kerry and Barry Laird took on the project and acquired a transmitter and microphones for parking lot worship. St. John's first parking lot worship took place on June 14, 2020. The worship team along with guidance from the Action Team, planned to expand worship to Strickfaden Park with social distancing and masks required on Sunday, July 17, 2020. Worship took place at Strickfaden Park until Sunday, October 18, 2020 returning to the church parking lot on Sunday, October 25, 2020.

Even though we were restricted by Zoom, parking lot and Strickfaden Park many blessings took place:

- The student blessings took place along with gift bags of supplies, treats and prayers for our youth as they returned to school.
- A facemask blessing to protect and show love for our neighbors.
- The pet blessing. Individuals sent pictures of their pets and Jenna Stacy put together a lovely slideshow, which was sent out in an email.
- Blessing of the quilts at Strickfaden Park. Quilters did not meet after March but still completed 50 quilts to be sent to Lutheran World Relief.
- God's Work, Our Hands Sunday: Ideas were submitted for servant events for each day in October. Allison Young created a calendar which went out to all members as well as yard signs saying "Hate has No Home Here." Members were encouraged to pick up signs and place them in their yards.
- Reformation month, we gathered items for a local nursing home.
- All Saint's Sunday celebrated the lives of June Gorga, Norma Zorn and Joan Zorn.

Planning continued to open the sanctuary for in person worship with reservations, social distancing and masks required. One service took place before Erie County went "red" which meant Covid cases were escalating. Decision made for the safety of St. John's members to return to parking lot and Zoom worship only.

The team then began planning for upcoming Advent and Christmas services. Hope was to be in the sanctuary but as the weeks and months moved towards Christmas, Covid cases were still escalating.

- Advent care packages delivered to all members. Packages included devotions, candles for an Advent wreath, candles for
- Christmas Eve worship and other items. Volunteers delivered packages to all members by Nov. 27, 2020.
- Pastor Stacy wanted to produce a video of a complete Christmas Eve worship service-taking place in the sanctuary. A videographer hired to video tape the service. DVD's will be available to members who do not have the internet.
- The sanctuary was decorated for the filming.
- Youth led worship on Dec. 13, 2020 on Zoom as their Christmas Youth Program.
- Christmas Eve worship planning to be held at Strickfaden Park at 4 pm if weather permits. Weather did not cooperate and service was held in the church parking lot along with Zoom worship at 8 pm.

This has been an unprecedented year. Our team came together to make worship available to all of St. John's members. We give thanks for the guidance and leadership of Pastor Stacy during these months. We pray that 2021 will bring us back together in the sanctuary worshipping our Lord and Savior. As we return, we will again need your help for lay readers, ushers, communion assistants. We look forward to the upcoming months with hope and anticipation.

## Finance Team — Team Leader: Ron Zorn

The Purpose of the Finance Team is to assist the treasurer and St John's Council with the financial business of the congregation. This includes such items as the implementation of the approved budget, overseeing of proper financial recording of contributions and disbursements, management of funds and reporting requirements. Current members of the team are: Peg Kingsley, Kevin Young, Ron Zorn, Kathy Scheid, Pastor Stacy and Ann Voight. In addition to the current members of the finance team, Clem and Candice Rudy provide an invaluable weekly service on the recording and counting of the offerings from the church membership. A special thank you to them for their service.

2020 has been a challenging year due to the pandemic.

Here are some highlights of the items the team has completed in 2020:

-Secured a PPP loan/grant from the federal government in the amount of \$18,177. It is anticipated that in 2021 the loan will be changed over to a grant once the guidelines are finalized by the government.

- With a change of employment of our financial advisor, we moved a portion of our cash from UBS to True Alpha Wealth Management

-With pandemic, cost cutting measures were instituted, pandemic supplies (masks, hand sanitizer, thermometer, sanitizing wipes) and a new piano for outside services, were secured.

-Reviewed HVAC maintenance agreements and secured 3 competitive bids for the church and parsonage insurance needs

-With the treasurer, the team developed the fiscal year budget for 2021 and provided budget assumptions and recommendations to Council. Pastor Stacy's salary for 2021 was determined by the minimum requirement recommended by the ELCA and a new HSA health plan was recommended.

- Because we are unable to meet in person because of the pandemic, the oversite committee will complete the financial review of 2020 financial records as soon as possible in 2021.

# Property Team — Team Leader: Jeff Justi

The Property Team members are: Jake Deehr, Don Johnson, Ryan Scovanner, Bob Stacy, Ray Witt and team leader Jeff Justi. Property Team responsibilities are to assess, monitor and maintain all St. John's properties including church, parsonage, and the cemetery.

The church passed its annual fire inspection from the Milan township fire department. State inspection of the elevator also passed.

We meet with Richard Dawkins, an audio specialist, who gave us tips and ideas on the state of the churches audio equipment.

The Safety and Property teams did an inspection of the church. Here are the new concerns implemented: 2 carbon monoxide detectors installed in the furnace rooms, new railing installed by the pulpit, the securing of the 2 metal cabinets in the basement, storing of cleaning chemicals in a secure area, and some new signage. The pothole was filled and some reflectors were placed on the pole in the parking lot.

We had a professional bidding process done for the parking lot resurfacing project to find out costs. After reviewing the bids and being in the midst of the pandemic with our doors shut, Property and Finance Team and church council decided not to have such a large capital expenditure. When things get back to normal we'll revisit the parking lot resurfacing.

This summer we had Hohler Furnace fix a persistent leak in the A/C unit of the parsonage. Hartland Mechanical performed routine maintenance on the churches heating and cooling units. Garbage service was switched to a new provider. Our lawn service provider notified us that they were discontinuing operations. This spring we will be looking for someone new to do this.

When the church closed its doors because of the pandemic we discontinued the cleanings services.

I would like to give a special thanks to Ann and Ray Witt and Ron Zorn for beautifying our landscape around the church and to all those wonderful volunteers that made this years Giving Garden a great success.

## 2020 Financial Reports – Key Summary Points

- Ordinary Income is positive this year at \$39,445 as compared to last year's ordinary income of \$19,509. A 102% improvement.
  - <sup>o</sup> Expenses were \$14,515 under last year. A 9% decrease.
    - Pastor expenses decreased \$3,503 from last year due mainly to no continuing education expense combined with decreased mileage reimbursement offset in part by the increase in health insurance.
    - Parsonage expenses decreased \$309 due mostly to lower propane costs.
    - Property taxes and insurance totals decreased \$700 primarily due to refunds from Ohio workman compensation account.
    - Office Expenses over all remained similar, telephone, office supplies and copier expense es decreased while Internet expense increased by \$500.
    - Church expenses decreased by \$9,700. Due to pandemic, costs decreased in janitorial services, liturgical supplies, propane usage and church maintenance.
    - Benevolence/Other expenses remained constant.
  - <sup>o</sup> Ordinary Offerings increased by \$4,620 over 2019 levels. A 3% increase.
  - ° PPP loan of \$18,177 is anticipated to be turned into a grant in 2021
- Cash Funds on the Balance Sheet increased \$59,426 and can be classified into the following categories: Note: Endowment Fund is not listed.

# Endowment Fund Report — John Miller/Ron Zorn

The purpose of the Endowment Committee is to oversee an Endowment Fund that is perpetual and uses its yearly increase in value over the principal amount to support ministries not normally funded by the operation budget of the church. The funds are guided by the Ohio Uniform Prudent Management of Institutional Funds Act and the assets are managed by a Professional Management Firm.

Members of the committee are Pastor Stacy Lauer- Scovanner, Kevin Young (President of Council), John Miller (Chair), Mary K Schlessman (Treasurer), Ron Zorn (Secretary), Bob Stacy, Jeff Justi and Colleen Shupe, who is filling a vacated positon due to the relocation of Dale Osbun Family. The committee thanks Dale for his valuable service and dedication on the committee.

The Endowment Fund Committee has the fiduciary responsibility to receive gifts and approve Grant applications, and distribute fund income on an annual basis. At the January 2020 Congregational Meeting, the congregation approved the recommendation of the committee to fund grants for fiscal year 2019 totaling \$27,515. In October 2020, 6 Grants were received and recommended to the Finance Team and Congregational Council totaling \$27,800. These grants will be presented to the Congregational Meeting in 2021 for final approval.

The fund began the year with a balance of \$580,069 of which \$463,768 was the principal. During the year donations of \$100 were received, and through November 2020 grant cash distributions were \$7,645 and management fees of \$5,190 were recorded. The ending balance of the fund at November 30, 2020 was \$608,658, of which \$463,868 is the principal.

# Action Team Report — Kevin Young

2020 – Action Team because – how to return to worship safely in our building – was just much to long of a name!

I created this Team to form ideas of 'What do we do now' after I took the unilateral decision to cancel services in late March when I was in St Petersburg, FL. That was a chilling experience.

The day before the international sports car race for the following weekend, IMSA at Sebring, FL was postponed as teams from outside the US were barred from leaving their country or faced a two-week isolation after their return. We had stood around one full day at the track (I was with IndyCar), with no sessions being run. Then in the morning, no fans were allowed access to the track and for every-one there was a single-entry point with a list of (now common) questions and our temperature was taken. Then NASCAR and I believe hockey were cancelled or postponed. We had cars on the race-track when in the middle of session 3, cars were stopped, and we were told – it is done. We were able to change our flights and return home safely, but that was just the beginning of the trauma and infection and death in the US.

We have worked since late March of 2020. Initially we had to learn, learn the science of a Pandemic.

A pandemic by definition is global! And wow – was there ever 'stuff' available to read – determining what was science compared to fluff was not easy.

Our charge – to return to worship in our building in a safe manner, meaning not infecting others, A huge challenge. As it turns out our small space did not make the immediately possible, so we turned our attention to other methods of worship. And here is where Pastor Stacy was able to shine! With Ann Voight's Parking Lot and in the Park worship idea and with Barry & Kerry leading the charge on the technical side – it was accomplished and continues to this day.

Also, Pastor was able to establish a digital worship service on Zoom – which continues to this day.

Here is where the Teams, primarily Worship Team and Faith Life Team, were able to put together ideas that have led us to have a daily 10:30 prayer gathering, plus book study, plus bible study on Zoom. Who would have guessed or even thought last January that we would have digital worship, surely not me.

Basically, rules established by the Ohio Department of Health (ODH) do not apply to a religious instruction such as ours – but we would be woefully remiss not to follow those best practices, as I just don't think a virus checks the buildings address before entering. To that point we have been following the ODH map - when we are red there is no worship in the Park.

We have had 1 service that was in person, in the building which required reservations, physical spacing, answering questions, and a temperature check and then we stopped as our county became red, and then purple! When the map recedes to yellow – we fully intend to re-start this service. There is good news, a few vaccines are now being distributed now.

I pray you are safe and not infected! Please join me in praying for this to be over and for us to be able to resume in person worship. And in the meantime, I will see you on Zoom, or in the parking lot or in the park.
